


Regulatory History

 - Oregon 1937
 - California 1946
 - Idaho unknown date
 - Montana 1930
 - Portions of B.C. 1982, 2003





Regulatory History

- Petitions to list fisher 1990, 1994, 2000
- April 2004 USFWS published 12-month finding of warranted, but precluded
- October 2014 USFWS

 published a proposed rule to
 list the West Coast DPS as
 threatened
- April 2016 USFWS withdrew the proposed rule to list
- Challenge in U.S. District Court

- Washington: Endangered
- Oregon: Protected, nongame species
- California: Southern Sierra threatened, Species of Special Concern







Oregon Surveys


- Remote cameras
- Scat-detection dogs
- Each symbol represents survey effort
- Red stars indicate fisher detection



NCSO Population Estimate

CDFW baited camera stations

- Fall 2010-2014
- Random placement
- Paired stations 1.6 km apart
- 14-30 days
- n = 462 stations


NCSO Population Estimate

Total population size 3,196 fishers (95% CI 2,507-4,184)

Average density
6.6 fishers/100 km²
(95% CI 5.1 – 8.6)




Resource Selection

- Fishers select resources at multiple spatial scales
- Home range
- Stand
- Patch
- Element




Home Range Selection and Movement

- Home range occupancy decreased as with increasing area of wetlands and logging
- Home range cores had intermediate amounts of landscape edge and high canopy cover forest





Ashland Watershed


- 2010 2017
- Filling regional information gaps
- Fisher response to fuels treatments
- Monitored fishers using VHF and GPS telemetry

Klamath-Siskiyou Carnivore Project

- Monitoring fishers with industry partners annually since 2006
- Impacts of reintroduction to source population
- Meso-predator community dynamics
- Impacts of mixed-severity wildfire
- 2017 expansion with ODFW



Rest Site Selection


- Select stands with large diameter trees, dense canopy cover, generally in drainage bottoms
- Select cavities and platforms in the largest live trees
- Steep slopes
- Greater log volume
- Hardwoods used more than expected





Reproduction and Dispersal

- 71% of adult females give birth
- Parturition occurs
 25 Mar (3 Mar 17 Apr)
- 65% weaned offspring
- Younger adult females are less successful
- Average litter size 2.3
- Mean female dispersal distance was 4.0 km

Sources of Mortality

- 70% predation
- 16% disease
- 10% toxicant poisoning
- 2% vehicle strike
- 2% other anthropogenic causes



Limiting Factors

- Evaluate the influences of ecological factors on survival and reproduction
 - Forest composition and configuration
 - Prey and predator abundances
 - Direct and indirect competition
 - Rodenticides




Northern Sierra Fisher Reintroduction


- Experimental
- Investigate fisher ecology on an commercially-managed landscape
- Establish a new population
- 2009-2011 reintroduced 40 fishers
- 2009-2017 intensive monitoring
- 2018-2026 noninvasive monitoring




